### **REGULATIONS AND COMPLIANCE**

Absorbents and spill containment products help you keep employees and work environments safe from unexpected spills, leaks, drips or other accidents. All plants are required to meet Federal regulations for liquid control. In addition, compliance with various regulations ensures that costly fines and negative impacts on an organization's reputation are eliminated. Absorbents are available for cleaning up oil, water and chemical based spills. Select from our line of absorbents and spill kits to help comply with the latest OSHA safety regulations. Other products are available to help comply with EPA, DOT and USCG Regulations.

**29 CFR 1910.22(a)(2)** — SUMMARY: Floors in your workplace should be "maintained in a clean and, so far as possible, a dry condition."

**29 CFR 1910.107(g)(2)** – SUMMARY: OSHA requires spraying areas to be "kept as free from the accumulation of deposits of combustible residues as practical."

**29 CFR 1910.1450(e)** – SUMMARY: OSHA requires containment and cleanup materials for spills in laboratories to reduce occupational exposure to hazardous chemicals

**29 CFR 1910.107(b)(3)** – SUMMARY: Combustible floors in a spray booth or work area "shall be covered with noncombustible material to facilitate the safe cleaning and removal of residues."

**29 CFR 1910.120(j)(1)** – SUMMARY: Commonly known as HAZWOPER, requires DOT containers and proper absorbents be kept available and used wherever spills, leaks or ruptures may occur.

#### MATS - PADS & ROLLS:

**29 CFR 1910.107(b)(3)** — If floors in a spray booth or work area are combustible, they "shall be covered with noncombustible material of such character as to facilitate the safe cleaning and removal of residues."

**29 CFR 1910.107(g)(2)** — OSHA requires spraying areas to be "kept as free from the accumulation of deposits of combustible residues as practical."

**29 CFR 1910.120(j)(1)** — Under an OSHA requirement, "DOT-specified salvage drums or containers and suitable quantities of proper absorbents shall be kept available and used in areas where spills, leaks, or ruptures may occur."

**29 CFR 1910.1450(e)** – OSHA requires containment and cleanup materials for spills in laboratories to reduce occupational exposure to hazardous chemicals.

**29 CFR 1910.22(a)(2)** — Floors in your workplace should be, "maintained in a clean and, so far as possible, a dry condition."

**49 CFR 173.3(c)(2)** — The area between a container and a salvage drum used for overpacking must have "sufficient cushioning and absorption material to prevent excessive movement of the damaged package and to eliminate the presence of any free liquid at the time the salvage drum is closed."

#### **SOCKS:**

**29 CFR 1910.120(j)(1)** — Under an OSHA requirement, "DOT-specified salvage drums or containers and suitable quantities of proper absorbents shall be kept available and used in areas where spills, leaks, or ruptures may occur."

**40 CFR 112.7(c)(1)** — Facilities must have "appropriate containment and/or diversionary structures to prevent discharge oil from reaching a navigable water course."

**40 CFR 263.30(a)** — In the event of a spill, transporters must, "take appropriate immediate action to protect human health and the environment."

**40 CFR 263.31** — Transporters, "must clean up any hazardous waste discharge that occurs during transportation...so that the hazardous waste discharge no longer presents a hazard to human health or the environment."

**49 CFR 173.3(c)(2)** – The area between a container and a salvage drum used for overpacking must have "sufficient cushioning and absorption material to prevent excessive movement of the damaged package and to eliminate the presence of any free liquid at the time the salvage drum is closed."

#### **PILLOWS:**

**29 CFR 1910.120(j)(1)** — Under an OSHA requirement, "DOT-specified salvage drums or containers and suitable quantities of proper absorbents shall be kept available and used in areas where spills, leaks, or ruptures may occur."

**33 CFR 154.1047(c)(2)** — Concerning navigation and navigable waters, a facility which handles, stores or transports Group V petroleum oils must identify response plan resources such as containment booms and other methods.

**40 CFR 112.7(c)(1)** – Facilities must have "appropriate containment and/or diversionary structures to prevent discharge oil from reaching a navigable water course."

**40 CFR 263.30(a)** — In the event of a spill, transporters must, "take appropriate immediate action to protect human health and the environment."

**40 CFR 263.31** — Transporters, "must clean up any hazardous waste discharge that occurs during transportation...so that the hazardous waste discharge no longer presents a hazard to human health or the environment."

**49 CFR 173.3(c)(2)** – The area between a container and a salvage drum used for overpacking must have "sufficient cushioning and absorption material to prevent excessive movement of the damaged package and to eliminate the presence of any free liquid at the time the salvage drum is closed."
